OUR MISSION

he Círculo de Empresarios is a think tank that brings together more than two hundred business people and senior executives from both national and multinational companies operating in Spain.

Its main aims consist of fostering the free market and private enterprise, achieving greater acknowledgement of the social value of business people as creators of employment, wealth and general well-being, and promoting an entrepreneurial spirit.

Under the motto "ideas for growth", the Círculo promotes the expansion of our economy and our businesses, improvements to the quality of our institutions and responsible and ethical conduct in the business world. The Círculo wishes to contribute with its thoughts on and proposals for improving Spanish society, at all times furthering the common good.

Registered as a non-profit organization, the Círculo is funded exclusively by the fees of its members who, on March 9, 2020, amounted to 201. The revenue budget for 2022 amounts to 1.7 million Euro from fees. The fees run in various tranches between 2,040 and 16,044 Euro per annum, primarily according to the number of employees of the businesses with whom the members are connected.

The Presidency and other positions on the Board of Directors are not remunerated. Solely the staff are remunerated, comprising fourteen individuals under the General Secretary.

LETTER FROM THE PRESIDENT



Manuel Pérez-Sala

would like to thank you all for the support and trust placed in me one year ago to lead the Círculo de Empresarios for a three-year term. On taking over from John de Zulueta on March 9, in my acceptance speech I summarised in broad terms what would guide my period in office: the defence of institutions; proposals for necessary structural reforms to ensure our future in terms of growth, well-being and employment in Spain and, finally, to offer up to society an exciting project for young people.

Spain is going through a particularly troubling period, with a Government continually raising challenges to the main institutions in the country. It is crucial to remember that the Crown, the Judiciary, the Armed Forces and Law Enforcement, along with independent regulatory and supervisory bodies, represent the guarantors of our freedoms and democracy.

The economic situation has deteriorated severely as a consequence of the Government's inadequate management of the pandemic. Our economy fared the worst during the pandemic and is currently showing the lowest growth among nearby countries. Our unemployment figures remain the worst in Europe and the necessary structural reforms have either yet to appear or are focused in the wrong direction.

Added to this is a rate of inflation that is out of control, becoming one of the most serious threats to our country. We are severely indebted, lack a realistic fiscal consolidation plan, are facing increasing interest rates and the prospect of the European Central Bank bringing its public debt acquisition policy to a close.

Even a major opportunity for Spain's modernisation, the Next Generation EU funds, could wind up being a disappointment due to a lack of transparency in terms of their assignment and the inability of the Government to manage these. There is a growing fear that it will not be possible to apply the European funds in the appropriate manner, either in terms of the amount or time frame.

The structural reforms upon which the European Union had conditioned the distribution of funds are proving to be particularly disappointing. What we have seen so far with respect to pension and employment reforms will increase labour costs and the fiscal burden on businesses and citizens and will be inadequate in terms of meeting two of the major challenges that we face: the sustainability of the Welfare State and creation of stable, high quality employment.

What is missing is a medium and long-term strategic outlook that contributes towards the viability of our society and the economy. A serious problem is the inability of politicians to recover the spirit of consensus that enabled our democracy, by coming together rather than turning against each other.

Within this context and at all times aiming for the common good, the Círculo has continued to speak out openly and constructively, providing ideas centred upon building a freer, fairer society that enables citizens to develop their lifelong projects, generating wealth for all within a context of equality of opportunity. We will see examples of this throughout this annual report.

I wish to thank H.M. King Felipe VI for his support and endorsement of the Círculo. His Majesty received the new Board of Directors at the Zarzuela Palace in July and participated in the VI Reino de España Business Career Award, which he presented to the Almeria businessman Francisco Martínez-Cosentino. I also wish to thank the presidencies of the Congress and Senate for their support to the **Executives** Parliament Programme (PEP).

Finally, of course, a thank you to the members, the Board of Directors, the Advisory Board and our team of professionals, who together make the selfless, open-handed project of the Círculo de Empresarios possible.





GENERAL SECRETARY'S REPORT

he activities of the Círculo's working groups during 2021 were especially intense and enjoyed a high degree of participation on the part of members. Although we were able to go back to face-to-face meetings, the possibility of attending online led to a slight increase in member participation. Thanks to this and to the commitment of its members, the Círculo was able to carry out its primary function as a think tank: generating ideas and proposals.

The matters on which the Círculo has given its opinion, conveyed to Spanish society, have been redirected according to the priorities set out by the new Chairman and the Board of Directors. On the one hand, we have set out our stall regarding the most urgent structural reforms that remain pending, relating to the pensions system and employment. As in previous times we have analysed the General State Budget for 2022 and expressed our doubts and recommendations regarding the management of European funds - a historic opportunity to transform our economy that we must make full use of.

The thoughts and proposals contained within the documents that form part of our endeavours in the defence of institutions, namely **Spain on the threshold of a decisive decade** and **A new bearing for Spain** were particularly significant. In these we speak out against the institutional crisis that we are experiencing and appeal to an urgent search for consensus in order to put aside partisan interests in the construction of a shared future project.

We also reacted to the Royal Decree on "Measures to mitigate the impact of rising prices in retail gas and electricity markets" with a note in which we stated that energy costs will increase still further and this will have a serious impact on legal certainty.

Other matters in which our members have actively contributed in defining our public position include current challenges with respect to Corporate Governance, highlighted in a series of debates, along with concerns around the deterioration of institutional quality, as mirrored in the Círculo's Business Survey.

The Círculo currently has twenty working groups and, as indicated in this Annual Report, a number of these have submitted documents throughout the year. Three new groups have been launched or reactivated during the past year: Real Estate, Pensions and Reform of Public Administrations and the Futures of Youth working groups. These are under the chairmanship of the members indicated in the corresponding pages. Alongside those of Fiscal Policy, Training and ESG, these groups are already preparing analyses and proposals that we will publish over the coming months.

I also wish to point out the successful second edition of the Forum on the Global Economy. This was held in collaboration with the Fundación Rafael del Pino and at long last offered both in person and online.

The chairman of the Círculo and his main spokespersons were present throughout the year on various forums and media platforms, conveying and broadcasting our ideas and proposals aimed at the common good and Spanish society as a whole.



EUROPEAN FUNDS, A MAJOR OPPORTUNITY FOR SPAIN

n March 18, we published a document on the importance of European Recovery Funds in overcoming the crisis brought about by Covid-19 and highlighted the **significant opportunity** that these represent in terms of tackling the **structural reforms** that are crucial for Spain; an opportunity which, if wasted due to a failure in terms of rollout, would be unforgivable.

The document, European funds, an opportunity that must be seized, was presented by the then Chairman of the Círculo, John de Zulueta, and the Chairman of the Economy and European Union Working Group, Juan María Nin.

Although these funds represent a significant demonstration of solidarity and a major step forward in the process of building Europe, they are, in turn, a major challenge with respect to the effective deployment of such a considerable amount of resources. There is also **strict conditionality** between the defrayal of the funds and progress in the rollout of the most urgent structural reforms (Pensions, Employment, Market Unity, Regional Funding and the sustainability of pu-



blic debt) aimed at achieving an economic model that is more competitive, robust, resilient, technological, sustainable and capable of generating increased growth, employment, equality and well-being.

BROAD CONSENSUS ON IMPROVING THE FUTURE FOR YOUNG PEOPLE

ncouraging the leading political forces to urgently **seek** consensus on building a shared future project, whilst putting aside partisan interests in favour of the common good, on June 2 we presented the document Spain, on the cusp of a decisive decade.

Our goal by way of this document is to contribute to the recovery of a culture based around pacts and build a better country for coming generations faced with high unemployment affecting particularly young people and an unsustainable level of **public sector debt** that threatens their future.

Both Manuel Pérez-Sala, Chairman of the Círculo, and Ingemar Naeve, Chairman of the Spain 2030 Working Group, participated in the presentation. It took place in the function room of the Madrid Press Association and was followed by a debate moderated by the journalist Fernando Jáuregui. RESTORING SOCIAL HARMONY, **DIALOGUE AND TOLERANCE**

n October 21 and in the auditorium of the law firm Pérez-Llorca Abogados, we published the document A new bearing for Spain. Coming together rather than turning against each other. Within this document we point out the urgency of a return to dialogue in politics, in order to get back to what is commonplace in everyday life: coexistence, dialogue and tolerance coinciding with the vast majority of citizens in the political centre ground.

As a consequence of having shifted from a two-party to a five-party system, the ridiculous ideological confrontation between right and left means that pacts may only be struck with parties on the fringe. As a result, we have radicalised administrations governing over citizens who are quite the opposite.

The presentation was made by the Chairman of the Círculo and the Chairwoman of the Institutional Relations Working Group, Carmen Mateo. This was followed by a debate moderated by the journalist Victoria Prego, in which the lawyer


CONCERN OVER THE DETERIORATION OF INSTITUTIONAL QUALITY

n October 5 we published the 2021 Business Survey, the results of which demonstrated the concern of the business people surveyed regarding the deterioration of institutional quality. This represents a threat to competitiveness and, as a result, calls out for the participation of the private sector in the selection of projects and management of European funds.

More than two hundred businesses of varying size and from differing sectors participated in the survey, which was Miguel Iraburu also presented the Círculo's Business Survey in Pamplona on November 16, at an event organised by the

NEW CHALLENGES IN CORPORATE GOVERNANCE

n July 21 we published the document Current Challenges in Corporate Governance, in which we brought together the conclusions of a series of discussion panels organised in order to analyse the challenges currently faced in terms of Corporate Governance, these having been accentuated largely by the health and economic crisis.

These panels were moderated by the deputy chair of the Círculo, Juan María Nin, along with Alberto Terol, Ignacio Moreno co-chairing the Corporate Governance Working.

GENERAL STATE BUDGET 2022: DIVORCED FROM REALITY AND LACKING FORESIGHT

ithin the context of the procedural clearance of the General State Budget Act for 2022, as in previous years we presented our analysis and opinion regarding the public accounts. The presentation on November 4 included Manuel Pérez-Sala and the Deputy Chairman and Chairman of the Economy and European Union working group of the Círculo, Juan María Nin.

The document, entitled PGE 2022: Divorced from reality and lacking foresight, highlighted the fact that the public accounts submitted by the Executive are short-term, focused on electioneering and further consolidate the structural deficit, whilst conforming to a macroeconomic framework that is outdated and unrealistic with respect to revenue and spending forecasts.

It likewise underlines the fact that, in contrast to neighbouring countries, the increased taxes levied on workers and businesses could hobble and delay the recovery of economic activity, entrepreneurship and investment at a time



in which it is essential to lay the foundations for increased potential GDP over the medium and long term.



A LABOUR REFORM AIMED AT **GENERATING STABLE EMPLOYMENT**

n November 11, we presented our proposal for labour market reform, aimed at creating an efficient labour market generating stable employment and defends the creation of an employment ecosystem that prioritises the unemployed. Both the Chairman of the Círculo and the Co-chair of the Employment and Diversity working group, Salvador Torres, participated in the presentation.

The document describes our labour market as "inefficient" and characterised by "high rates of temporary employment and unemployment, with a lack of flexibility and inadequate skills training". In short, a labour market that protects solely those with permanent contracts, rather than people on temporary contracts or the unemployed.

We commit to the simplification of contract types together with a reduction in compensation for dismissal, the aim being to bring an end to seasonal employment and reduce unemployment.





DELAYING THE RETIREMENT AGE BY MEANS OF AN INCENTIVE SYSTEM

n November 22 we presented our proposal for reforms to the pensions system, entitled An urgent reform to our pensions system. This highlighted the pressing need to transform the system with long-term foresight in order to ensure its sustainability, balance, efficiency and respect for inter-generational solidarity.

Among other measures, we defend the need to postpone the target age of retirement to 70, essential in order to maintain the current level of the state pension; we advocate for the creation of an individual, notional accounts system as already successfully deployed in nearby countries, to ensure the sustainability of the system and provide greater transparency. We are in favour of encouraging complementary funding for retirement out of private savings, or the establishment of the "Austrian backpack" model, increasing the amount of savings for retirement.

Carmen Mateo, Chairwoman of the Círculo's Institutional Relations working group; Isabel Dutilh, Chairwoman of the Legal Certainty group and Alberto Terol, Deputy Chairman of the Círculo and Cochair of the Corporate Governance group also participated in the event.

In addition to labour reforms, the re-

form of the pensions system, tax system and education, the latter aimed at strengthening dual vocational training and redesigning the university system and public administrations, Pérez-Sala insisted on the need for **solid institutional infrastructure** for the **proper functioning of the economy**.

VIII CRE100DO ANNUAL EVENT

n November 16, the **CRE100DO** Foundation, of which the Círculo de Empresarios is a founding patron, held its VIII Annual Event in the Círculo de Bellas Artes, where the main conclusions of the survey "The importance of Spanish Medium-Sized Enterprises for the country's economy" were presented, along with the twelve new companies that joined the Foundation's ecosystem.

The event was concluded by Nadia Calviño, the first Deputy Prime Minister of the Spanish government and Minister of Economic Affairs and Digital Transformation, and was the setting in which our Chairman stated that "the most important thing is the qualitative aspects of the middle market, its dynamism, capacity for growth, potential in terms of innovation and the fact that these are internationalised businesses. It is the most dynamic segment of Spain's business fabric".

The goal of CRE100DO is to contribute actively to the development of the economic fabric of the country by means of larger, more innovative, more international and competitive businesses. It has become a benchmark among Spanish middle market businesses that represent more than 1.5% of the country's GDP, with aggregate turnover of EUR 16.5 billion and 85,000 direct employees.

II GLOBAL ECONOMY FORUM

n October 14, the Círculo de Empresarios and the Rafael del Pino Foundation held the II Global Economy Forum, aimed at debating the world economic situation and outlook.

This II edition of the Forum was opened by the chairs of the respective entities, Manuel Pérez-Sala and María del Pino, and enjoyed the participation of well-known national and international panellists on two discussion panels focused on the activation of the economic and social recovery and insights into structural challenges. In contrast to the situation in 2020, it was possible to hold this second edition in a mixed format (face-to-face and virtual).

The first block of the Forum led to a conversation around the economic consequences of the pandemic; the impact on global trade and its recovery; how to ensure cohesion in terms of recovery and the current geopolitical challenges.

It benefited from the participation of Ignacio de la Torre, Partner and Chief Economist at Arcano Partners and Chairman of the Advisory Board of the Círculo; Silvia Iranzo, Independent Director of Indra and the ICO, former Secretary of State for Trade; Emma Navarro, Former Deputy Chair of the BEI and independent director; and Emilio Lamo de Espinosa, member of the Royal Academy of Moral and Political Sciences. FORUMS OF THE CÍRCULO

We were able to benefit from the presence of **Antonio** Garrigues Walker, Chairman of the Garrigues Foundation and one of the most reputable Spanish legal experts in the world. In the forum, he presented his latest book "Surviving to tell the tale".





The former Prime Minister of Portugal and then member of the Advisory Board of the Círculo, Pedro Passos Coelho dealt with the political and economic challenges of the recovery process in the European Union.

Organised by the Science and Innovation working group, Teresa Riesgo, the General Secretary for innovation, spoke about the role of science and innovation as one of the ten key policy tools around which the Recovery, Transformation and Resilience plan is structured.





The General Secretary for Economic Affairs and the G20 of the Prime Minister's office, Manuel de la Rocha, spoke with our associates regarding the challenges and opportunities offered by the Next Generation EU funds.



The Chairwoman of the Independent Fiscal Accountability Authority (Autoridad Independiente de Responsabilidad Fiscal - AIReF), **Cristina Herrero**, analysed the situation of the Spanish economy as it passed through an unprecedented crisis brought about by the Covid-19 pandemic and the marked differences from the previous financial crisis of 2008.

The First Deputy Prime Minister of the Government and Minister for Economic Affairs and Digital Transformation, Nadia Calviño, visited the Círculo's offices in order to deal with various matters, such as the gradual withdrawal of extraordinary support measures deployed as a consequence of the health crisis, the increase in the minimum wage and the measures announced by the Government with respect to the electricity sector.





The chairwoman of the Competition and Markets Authority (Comisión Nacional de los Mercados y la Competencia - CNMC), Cani Fernández, spoke of the impact that Next Generation EU funds could have and the risks that this state assistance could entail in terms of competition and market liberalisation.

MEETING WITH PABLO CASADO

On June 18, the leader of the opposition and Chairman of the Partido Popular, Pablo Casado, attended a meeting with our Chairman at the offices of the Círculo de Empresarios, in which they discussed the political and economic situation of the country whilst agreeing that support for the Constitution and the rule of law remain essential pillars for the recovery of employment and preservation of the welfare state.




